Dear Dr. Wendroff:

There are several aspects of the public health hazard of mercury. ATSDR is examining the health risks from mercury from the perspective of toxicology, exposures at hazardous waste sites especially biota and the accidental exposure in homes, schools and the general environment. ATSDR has publications on the toxicology of mercury. Including the toxicological profile on mercury, a peer reviewed document.

Your letter expressed specific concerns about the use of mercury in religious practices and a project that was conducted by the Connecticut Department of Health Services (CDHS) and ATSDR in Hartford, Connecticut. This was an investigation of the factors associated with use of mercury in religious practices by some members of the Hispanic community in the greater Hartford area. The objective of the study was to survey the basic knowledge on the popular use of Azogue among Hispanic and other ethnic groups. The project had two phases, the determination of ethnic factors which influenced the religious use of mercury and the development of bilingual/bicultural educational materials that would increase community awareness on potential health risk from mercury. The CDHS staff indicated that while sampling was not an objective of the study sampling of homes was attempted. However, CDHS, the Hartford Health Department, and the Hispanic Health Council were unable to obtain permission. From the residents to either sample their homes for biomedical tests. The principle investigator pointed out that attempts by health agencies to force sampling of private homes has caused the Hispanic community to deny the use of the Azogue and impaired the ability of the public health agencies to institute effective prevention programs. The Connecticut study achieved the objective of defining the scope of the practice in a Northeastern city and forms the basis for the development of effective preventive public health messages. Further, the findings have shown that public health interventions must respect the culture of the hispanic communities in order to be successful.
